MINUTES

Mayor Clarence R. Fields and the Council of the City of Pineville, Louisiana, met in regular session on Tuesday, February 14, 2017 at 6:00 p.m. in the Council Chambers of City Hall, 910 Main Street, Pineville, Louisiana.

- 1. Mayor Fields called the meeting to order.
- 2. Councilman Martin gave the invocation.
- 3. Michaela Triche, a Senior at Pineville High School who is job shadowing Mayor Fields as required for credit on her Senior Project, led the Pledge of Allegiance.

- 5. A motion was made by Councilman Dorn and seconded by Councilwoman Galloway to accept the minutes of the January 10th meeting as published. The floor was opened for public comment. On vote, the motion carried.

9. Condemnation Hearings

A. Mr. Tom David reported on the condemned structure on property located at 103 Burns Street, belonging to William K. Norton. The property owner has given the City permission via letter from the owner's daughter, Aimee Norton, who has power of attorney, to demolish the structure and clear the lot as needed. WHEREAS, after recent high flood stages in the Red River, City Public Works personnel have reported locations of severe erosion of the batture on the left descending bank of the Red River, just downstream of the Gillis Long Bridge; and,

WHEREAS, the erosion has developed to such a degree that it is now threatening the riverfront walking path that runs along the batture and leads to the Historic Fort Buhlow State Park; and,

WHEREAS, if the erosion continues and damages the riverfront walking path, the next public assets to be at risk will be water mains, sewer force mains, electric power lines, and Riverside Drive; and,

WHEREAS, the City believes that the maintenance and repair of the river erosion in the batture to be the responsibility of someone else other than the City, and,

WHEREAS, the current erosion, if unabated, will in short order be a threat to the public health and safety of residents of the City by threatening loss of use of the trail, disruption of access to residential and public assets, and catastrophic disruption of water and sewer service for area residents; and,

WHEREAS, a plan of action and funding needs to be developed by appropriate responsible parties to primarily stop further erosion and secondarily to correct the eroded area as it currently exists; with such abatement and corrective work to be undertaken sooner than later.

NOW THEREFORE BE IT RESOLVED, that the City of Pineville hereby request that representatives of the U.S. Army Corps of Engineers; along with Red River Atchafalaya &Bayou Boeuf Levee District and Red River Waterway Commission make a site visit and help determine the extent of riverbank erosion, and develop a plan of action for corrective work; and,

BE IT FURTHER RESOLVED, that upon development of the plan of action for corrective work by the appropriate responsible party(s) that said plan be forwarded to the City along with a timetable for implementation of the critical corrective work; and,

BE IT FURTHER RESOLVED, that a copy of this Resolution is forwarded to the U.S. Army Corps of Engineers, Red River Atchafalaya & Bayou Boeuf Levee District, Red River Waterway Commission, the Congressional delegation, and State Representative Jeffrey Hall, State Representative Chris Hazel, and State Senator Jay Luneau.

WHEREAS, the City of Pineville deems it in the best interests of the City and its citizens to authorize the Mayor to negotiate and enter into an amendment of said Cooperative Endeavor Agreement and make modifications deemed necessary and/or in the best interests of the City of Pineville and its citizens.

NOW, THEREFORE BE IT RESOLVED, that Mayor Clarence R. Fields is hereby authorized and empowered to negotiate and enter into an amendment of said Cooperative Endeavor Agreement to make modifications deemed necessary to include the Town of Colfax (TOC), Louisiana, in the agreement.

WHEREUPON, a motion to approve the foregoing resolution was made by Councilman Martin and seconded by Councilman Bouchie. After the floor was opened for public comment a vote was taken and it was the unanimous decision of the members of the Pineville City Council that the Resolution be duly adopted on this 14th day of February, 2017.
