A MEETING OF THE MAYOR AND COUNCIL CITY OF PINEVILLE, LOUISIANA JANUARY 8, 2019 – 6:00 P.M.

MINUTES

Mayor Clarence R. Fields and the Council of the City of Pineville, Louisiana, met in regular session on Tuesday, January 8, 2019 at 6:00 p.m. in the Council Chambers of City Hall, 910 Main Street, Pineville, Louisiana.

- 1. The Mayor called the meeting to order.
- 2. Pastor Brett Dupuy, gave the invocation.
- 3. Councilman Bouchie led the Pledge of Allegiance.

 - 5. A motion was made by Councilwoman Galloway and seconded by Councilman Bouchie to accept the minutes of the December 11th meeting as published. The floor was opened for public comment. On vote, the motion carried.

 - 7 & 8. <u>ZONING COMMISSION REPORTS</u> Mr. Tom David, Chairman, stated that at a meeting of the Zoning Commission which was held at 5:30 p.m., it was resolved to recommend to the Mayor and Council that the companion properties located at 100 & 102 Al Street, belonging to Susan LaHood, zoned as C-1(Commercial) be zoned as C-2(Commercial) and the property located at 104 Al Street, belonging to Rebecca Ellison & Mary Epps, zoned as R-1(Residential) be zoned as C-2(Commercial.) Mr. David stated that this recommendation of approval for the above properties extends with the stipulations that development of a carwash must be completed in 3 years. In the event that a carwash is not built during this time, all of the properties would revert back to C-1 zoning. A motion was made by Councilman Martin and seconded by Councilwoman Frederic to approve a resolution 16. providing for canvassing the returns and declaring the result of the special election held in the City of Pineville, State of Louisiana, on Saturday, December 8, 2018, to determine whether the sale of beverages of high and low alcoholic content shall be permitted within the corporation limits of the City of Pineville:

BE IT RESOLVED by the Mayor and Council of the City of Pineville, State of Louisiana (the "Governing Authority"), acting as the governing authority of City of Pineville, State of Louisiana (the "City"), that:

SECTION 1. Canvass. This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the City of Pineville, State of Louisiana, on December 8, 2018, to determine whether the sale of beverages of high and low alcoholic content shall be permitted within the corporation limits of the City of Pineville, and said Governing Authority does further proceed to examine and canvass the returns and declare the result of the special election.

Procès Verbal. A Procès Verbal of the canvass of the returns of said special election shall be made SECTION 2. and certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in the office; another copy thereof shall be forwarded to the Clerk of Court and Ex-Officio Recorder of Mortgages in and for the Parish of Rapides, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

SECTION 3. Promulgation of Election Result. The result of said special election shall be promulgated by publication in the manner provided by law.

BE IT KNOWN AND REMEMBERED that on January 8, 2019 at six o'clock (6:00) p.m. at its regular meeting place, the Council Chambers of Pineville City Hall, 910 Main Street, Pineville, Louisiana, the Mayor and Council of the City of Louisiana (the "Governing Authority"), acting as the governing authority of the City of Pineville, State of Louisiana (the "City"), and being the authority ordering the special election held therein on Saturday, December 8, 2018, with the following members present: Mary Galloway, Kevin Dorn, Christy Frederic, Tom Bouchie and Nathan Martin

did, in open and public session, examine the official certified tabulations of votes cast at the said special election, and did examine and canvass the returns of said special election, there having been submitted at said special election the following propositions to wit:

PROPOSITION No. 1

Shall the sale of beverages of alcoholic content containing not more than six percent alcohol by volume be permitted by package only and not for consumption on the premises in the City of Pineville, State of Louisiana?

PROPOSITION No. 2

Shall the sale of beverages of alcoholic content containing not more than six percent alcohol by volume for consumption on the premises be permitted in the City of Pineville, State of Louisiana?

PROPOSITION No. 3

Shall the sale of beverage alcohol containing one-half of one percent alcohol by volume and above for consumption on the premises be permitted in the City of Pineville, State of Louisiana?

PROPOSITION No. 4

Shall the sale of beverages of alcoholic content containing one-half of one percent alcohol by volume and above by the package only and not for consumption on the premises be permitted in the City of Pineville, State of Louisiana? PROPOSITION No. 5

Shall the sale of beverages of high and low alcoholic content be permitted only on the premises of restaurant establishments which have been issued an "R" permit as defined by law in the City of Pineville, State of Louisiana?

There was found by said count and canvass that the following votes had been cast at the said special election IN

FAVOR OF and AGAINST, respectively, the propositions as hereinabove set forth, to-wit:

Proposition #1 - a total of 1,143 votes were cast **IN FAVOR OF** Proposition #1 and a total 695 votes were cast **AGAINST** Proposition #1, as hereinabove set forth, and that there was a majority of 448 votes cast **IN FAVOR OF** Proposition #1 as hereinabove set forth.

Proposition #2 - a total of 1,169 votes were cast IN FAVOR OF Proposition #2 and a total 673 votes were cast AGAINST Proposition #2, as hereinabove set forth, and that there was a majority of 496 votes cast IN FAVOR OF Proposition #2 as hereinabove set forth.

Proposition #3 - a total of 1,175 votes were cast **IN FAVOR OF** Proposition #3 and a total 663 votes were cast **AGAINST** Proposition #3, as hereinabove set forth, and that there was a majority of 512 votes cast **IN FAVOR OF** Proposition #3 as hereinabove set forth.

Proposition #4 - a total of 1,349 votes were cast IN FAVOR OF Proposition #4 and a total 552 votes were cast AGAINST Proposition #4, as hereinabove set forth, and that there was a majority of 797 votes cast IN FAVOR OF Proposition #4 as hereinabove set forth.

Proposition #5 - a total of 1,414 votes were cast IN FAVOR OF Proposition #5 and a total 490 votes were cast AGAINST Proposition #5, as hereinabove set forth, and that there was a majority of 924 votes cast IN FAVOR OF Proposition #5 as hereinabove set forth.

Therefore, the Governing Authority did declare and proclaim and does hereby declare and proclaim in open and public session that Propositions #1 - #5 as hereinabove set forth were duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the said special election held by the City on Saturday, December 8, 2018. The floor was opened for public comment. On vote, the motion carried. Roll call was as follows:
