MAYOR AND COUNCIL November 12, 2024 – 6:00 P.M.

MINUTES

Mayor Joe Bishop and the Council of the City of Pineville, Louisiana, met in regular session on Tuesday, November 12, 2024, beginning at 6:00 p.m. in the Council Chambers of the City Hall, 910 Main Street, Pineville, Louisiana

- 1. Mayor Bishop called the meeting to order.
- 2. Councilman Martin gave the invocation.
- 3. Councilman Dorn led the Pledge of Allegiance.

- 5. The floor was open for public comment on any agenda item and there were none.
- 6.. A motion was made by Councilman Dorn and seconded by Councilman Bouchie to accept the minutes of the October 8, 2024, regular meeting as published. There was no Council discussion. On vote, the motion carried unanimously.
- 7. A motion was made by Councilman Martin and seconded by Councilwoman Frederic to accept the minutes of the October 30, 2024, special meeting as published. There was no Council discussion. On vote, the motion carried unanimously.
- 8. A motion was made by Councilwoman Frederic and seconded by Councilman Dorn to accept the financial report as read by Finance Director, Mr. David Humphries. Mr. Humphries reported that both our sales tax and occupational license collections were up year-over-year; 5.43% and 15.71% respectively. There was no Council discussion. On vote, the motion carried unanimously.
- 9. Ms. Cindy Rushing, Rapides Parish School Board Early Childhood Director, gave a presentation on available scholarships for Rapides Parish residents/children age three and under. Her organization works with 35 childcare centers, and Head Start/Pre-K programs within Rapides Parish. They have a tuition assistance program through a State grant and partnerships with The Rapides Foundation, The Orchard Foundation, the Rotary Club of Alexandria, and the Rapides Parish School Board. The program offers assistance to families who cannot afford to pay for a quality early childhood education. Through grants and fundraising efforts, they raised \$4.7M to serve 300 to 350 children ages birth to three. Those scholarships are free to families who qualify. - 10. A motion was made by Councilman Dorn and seconded by Councilwoman Frederic to table the recognition of Captain Shane Kessler and Captain Michael Richard of the Pineville Fire Department for their life saving efforts on August 24, 2024, during a structure fire. There was no Council discussion. On vote, the motion carried unanimously.
- 11. CONDEMNATION HEARING for 2024-041, regarding the multi-family home near the corner of Bell Street and Mills Road, described as .56 AC IN SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 7, TOWNSHIP 4 NORTH, RANGE 1 EAST; 215' X 114', owned by Corine H. Roland ET AL, listed with the address of 116 Jo Ann Drive, Pineville, Louisiana 71360, according to the Rapides Parish Tax Assessor records. City Engineer, Mr. Tom Daivd, reported this is a continuation a the request of the owner and no one representing the owner was in attendance. Mr. David stated the City received a letter from J Roland Enterprises outlining improvements to the property that have been made. Mr. David requested for another extension to be able to speak with the Rolands about the property.

At that time he can make a recommendation. However, if there is no representation, he will recommend the property be condemned because it is in bad condition. Mayor Bishop explained Mr. Roland has been in touch with the administration regarding the property and has filed for permits. It is believed our building inspector will be able to provide a report through the permitting process.

A motion was made by Councilman Dorn and seconded by Councilman Bouchie to grant an extension for this hearing to the December meeting. There was no Council discussion. On vote, the motion carried unanimously.

20NING COMMISION REPORT: Zoning Commissioner, Mr. David, stated that it is the Zoning Commission's recommendation to approve a petition for annexation of 0.97 acres of property located at 2514 Donahue Ferry Road, belonging to Darren and Mary Lee Green, Mr. David noted the petitioner requested to be zoned as R-1 (Residential) and the Commission has no objections. A motion was made by Councilman Bouchie and seconded by Councilman Martin to accept the recommendation. Councilman Bouchie stated that Mr. Green thought he was already in the City Limits, so this action will correct the record. Mayor Biship emphasized this action will help to square up the City Limits along Donahue Ferry Road. No other comment was heard from the Council. On vote, the motion carried unanimously. Roll call was as follows:

13. ZONING COMMISSION REPORT: Regarding a petition for variance of setback requirements relative to property located at 230 Dillon Street, belonging to Inner-city Revitalization Corp. Mr. David stated it was the Zoning Commission's recommendation to approve this petition. He said the variance request is to reduce the setback requirements, for the lot on the corner of Dillon and Sanders Street, from 20' to 12'. Additionally, Mr. David pointed out during the Zoning Commission Meeting, it was discovered the entirety of the property along Dillon Street owned by Inner-city Revitalization Corp (which includes: 206 Dillon Street, 212 Dillon Street, 216 Dillon Street, 220 Dillon Street, 224 Dillon Street and 230 Dillon Street) is currently zoned as C-3 Commercial. With the petitioner's concurrence, the Zoning Commission would like to recommend correcting this by rezoning all the property to R-2 Residential.

A motion was made by Councilman Dorn and seconded by Councilman Matin to accept the recommendation. Councilman Bouchie explained he is usually against a request for variance. However, he supports this because of the improvements to Dillon Street it will bring. Councilman Dorn applauded Inner-city Revitalization Corp for their efforts to develop affordable housing is wealthy challenged communities. Mayor Bishop expressed gratitude toward the corp. as well for purchasing the property and cleaning up the neighborhood. No other comment was heard from the Council. On vote, the motion carried unanimously. Roll call was as follows:

- 14. ZONING COMMISSION REPORT: Regarding a petition for variance of the Mobile Home Overlay Ordinance to allow for a mobile home to be placed on a lot located at 417 Hickory Street, belonging to Hernandez Homes LLC, and that mobile home be allowed to be older than 5-years of age. Mr. David reported the petitioner withdrew the petition during the Zoning Commission Meeting after some robust discussion. The petition highlighted some potential updates that may need to be made to our Ordinance. Therefore, there is no action needed.
- 15. A motion was made by Councilman Martin and seconded by Councilwoman Frederic to adopt an ordinance to amend and modify the Code of Ordinances, by adding Chapter 6, Article III, Section 6-54, to establish a Community Cat Program. There was no Council discussion. On vote, the motion carried unanimously. Roll call was as follows:

17. A motion was made by Councilman Bouchie and seconded by Councilman Dorn to approve a resolution to amend account information for accounts held by Red River Bank. There was no Council discussion. On vote, the motion carried unanimously.

18. A motion was made by Councilman Martin and seconded by Councilman Bouchie to nominate Mr. Randy G O'Neal for appointment as Interim District 1 Councilmember in accordance with La. R.S. 18:602. Councilman Martin expressed gratitude to the several individuals who were willing to serve. However, because of Mr. O'Neal's presence at meetings over the years and the fact that he is the originator of #pinevilleproud, he is excited to make the nomination. No other comment was heard by the Council. On vote, the motion carried unanimously. Roll call was as follows:

-- Mayor Bishop "thanked" former Councilmember Mary Galloway for her many years of service to the citizens of Pineville and District 1.

-- Mr. O'Neal then came forward to be sworn in by City Judge, Gary Hays. After Councilman O'Neal was sworn in, he took his place on the dais.

- 19. A motion was made by Councilman Frederic and seconded by Councilman Bouchie to approve a resolution authorizing the Mayor to execute any and all documents related to entering a lease-purchase agreement with Government Capital Corporation for the purpose of financing a license plate reader, vehicles, heavy equipment and other equipment. There was no Council discussion. On vote, the motion carried unanimously.
- 20. A motion was made by Councilman Dorn and seconded by Councilman Martin to approve a resolution authorizing the Mayor to negotiate and enter into a cooperative endeavor agreement with North Rapides Crime Stoppers, Inc. In response to a question from Councilman Dorn, Police Chief Darrel Basco reported the (North Rapides Crime Stoppers) Board is ready to begin expenditure of funds, as soon as the agreement is done and money is transferred. The Board has done a great job of ensuring steps have taken place to be ready in January. Mayor Bishop took this opportunity to reiterate that his office and the Council are looking forward to working Marshal Rachal, Judge hays and their staff. Chief Basco then gave kudos to Judge Hays for conceiving the idea. He also recognized State Representative Mike Johnson who helped with getting some special legislation passed and signed by the Governor for this effort. Chief Basco explained this organization is independent from the Crim Stoppers across the river. No other comment was heard by the Council. On vote, the motion carried unanimously.
- 21. A motion was made by Councilman Martin and seconded by Councilman Dorn to approve a resolution awarding the contract for AUXILIARY POWER (GENERATORS AND SWITCH GEAR IMPROVEMENTS AT PRIMARY WATER WELLS (LAKEVIEW STREET AND O'NEAL STREET) & BOOSTER PUMP STATION IMPROVEMENTS (JANET DRIVE, LAKEVIEW STREET AND O'NEAL STREET) and authorizing the Mayor to execute contracts, change orders and other documents related to the project between the City of Pineville and the selected Bidder. There was no Council discussion. On vote, the motion carried unanimously.
- 22. A motion was made by Councilman Bouchie and seconded by Councilwoman Frederic to approve a resolution declaring the following items in the Pineville Police Department as surplus for the purpose of selling, donating, auctioning or disposing of as necessary.
